## a. Membership Sign-up/Renewal Terms and Conditions

1. Dependent Membership Promotion is only applicable for:
  - a. Female spouses and children (aged 5-20)
  - b. New sign-ups/renewals from 1 Oct - 30 Nov 19 (both dates inclusive)
  - c. 2-year or 5-year Dependent Membership term
2. Dependent membership must be accompanied by a valid Principal membership and the expiry date of the Dependent membership must not exceed that of the Principal membership.
3. Expiry date of the Dependent membership cannot exceed that of the Principal membership. Its validity and related privileges shall lapse when the Principal member resigns or ceases to be a SAFRA member, or is suspended when his membership is not renewed. Dependent membership for the child will lapse when the child reaches 21 years of age or when the child enters National Service, whichever is earlier. Maximum membership tenure is capped at 12 years (i.e. until 2031).
4. Female spouses and children of Ordinary A (excluding NSFs)/ B/ Associate/ Life members are eligible for Dependent Membership.
5. Child Dependent members' age must be lower than 21 years old at the end of the membership tenure.
6. For a **female spouse's** new application, a **copy of marriage certificate** is required as documentary proof.

7. For a **child's** new application, a **copy of birth certificate** is required as documentary proof.
8. Maximum membership tenure including advance renewal is capped at 12 years (i.e. until 2031).
9. **Not applicable to members who have enjoyed prevailing promotion (i.e. \$5-per-year Dependent membership) at SAFRA Membership Roadshow @ Lot One (10-13 Oct 19).**
10. Strictly no refund of membership fees for all sign-ups/renewals.
11. SAFRAPOINTS cannot be used to pay for SAFRA Membership application or any other ongoing SAFRA Membership promotions.
12. This promotion is only valid for one-time sign-up only.
