

## TERMS & CONDITIONS

### **SAFRA DEPENDENT LUCKY DRAW 1 JULY – 31 OCTOBER 2018**

1. SAFRA Dependent Lucky Draw (the “Draw”) is open to all SAFRA Dependent members, except for employees of SAFRA and their immediate families and any other parties who are directly involved in organising or conducting the Draw as determined by SAFRA.
2. From 1 July to 31 October 2018 (“Promotion Period”), all SAFRA Dependent members will be entitled to participate in the lucky draw with **a minimum sign up/ renewal of 2-year SAFRA Dependent Membership** (“Eligible Member”).
