4. Strictly no refund of membership fees for all sign-ups/ renewals.
5. NS50 SAFRA Vouchers can be used Dependent Membership sign-ups/renewals.
6. **For a female spouse's new application**, a copy of **marriage certificate** is required as documentary proof.
7. **For a child's new application**, a copy of **birth certificate** is required as documentary proof.
8. Dependent membership must be accompanied by a valid Principal membership and the expiry date of the Dependent membership must not exceed that of the Principal membership.
9. Child Dependent members' age must be lower than 21 years at the end of the membership tenure.
10. Expiry date of the Dependent membership cannot exceed that of the Principal membership. Its validity and related privileges shall lapse when the Principal member resigns or ceases to be a SAFRA member, or is suspended when his membership is not renewed. Dependent membership for the child will lapse when

the child reaches 21 years of age or when the child enters National Service, whichever is earlier. Maximum membership tenure is capped at 14 years (i.e. until 2032).

11. This promotion is only valid for one-time sign-up only.
12. These Terms and Conditions shall be read in conjunction with the SAFRA General Membership Terms & Conditions. In the event of any inconsistency, these Terms and Conditions shall prevail.
